### **Responsibilities:**

- A. Design 35 promotional posters after reviewing the online course content.
- B. Working on illustrations for the posters based on the design and theme.
- C. Creating and communicating design options and illustrations suitable for the posters.
- D. Design 2 primers of 30 pages each based on the content shared by the respective teams.
- E. Create illustrations and data visualizations for the primers.
- F. Finalizing the design and illustrations for the posters and primers based on feedback and in coordination with the Project 39A staff.

- A. Graduate in Fine Arts, Graphic Design or any related field.
- B. Relevant experience of working as a designer.
- C. Relevant experience of working with a reputed graphic design firm.
- D. Good hold over design softwares like Adobe Photoshop, Illustrator, InDesign, Coral Draw etc.
- E. Experience in working with print medium.
