About the Course

The Advanced Certificate Course on International Law builds upon the basic concepts of International Law generally taught in a LL.B/LL.M Degree as well as in other allied degrees. The objective of this course is to cover four major and important areas of international law from the practical perspective, namely: Sources of International Law, Law of Treaties, Law of State Responsibility and Dispute Resolution. These areas are of general importance and application across different specialised areas of international law and therefore their thorough understanding is necessary. The Focus of the Course shall be on the detailed application of these areas which are though contemporary and relevant but scarcely included in regular curriculum and teaching-learning process.

Who Must Apply

Students looking to participate and win in International Law Moot Competitions, Researchers and Teachers keen on building upon their basic concepts of International Law, especially from a practical perspective, Lawyers and Professionals looking to deepen their practical exposure to International Law

Evaluation Criteria and Course Pedagogy

Eighty percent of the evaluation shall be done via a Take home exam. Students will have 8 hours to respond to one problem based question, which will touch upon the course covered. Students will be assessed based on their understanding and analysis of the taught course. The rest of the twenty percent is allocated for Class participation.

Expected Outcome

A sound understanding of the oft-used and disputed areas of International Law viz., the Sources of International Law, Law on Treaties, Relationship between the Sources of International Law, Conflict and Hierarchy of Norms and Law on State Responsibility. Learning about the Dispute Resolution Mechanism under various areas of International Law is also an integral part of the learning outcome from this course. This expected outcome shall benefit students, teachers, Lawyers and professionals equally in all their areas of interface with International Law. Law students particularly interested in moot activities will be especially benefitted as complex moot problems in International Law have the above mentioned areas of International Law at their core.
