#### JOINT MASTERS/LL.M. IN INTELLECTUAL PROPERTY (IP) LAW AND MANAGEMENT

#### **ELIGIBILITY CRITERIA:**

#### Masters of Arts (M.A.) in Intellectual Property Law and Management (One Year Programme)

- (i) Candidates must have completed two bachelor's degrees in succession, including one in the relevant discipline; or
- (ii) An integrated degree programme of five years in the relevant discipline after completing plus two; or
- (iii) An equivalent post-graduate degree in any discipline from a recognized university; or
- (iv) Candidates completing a four-year Bachelor's programme with Honours/Research, from a recognized university In all the above mentioned cases, the candidate must have secured a minimum of 55% marks in aggregate (50% for reserved categories such as SC/ST/Persons with Disability).

#### Master of Law (LL.M.) in Intellectual Property Law and Management (One Year Programme)

Candidate should have completed LL.B. or an equivalent degree from a recognized University with a minimum of 55% marks in aggregate (50% for reserved categories such as SC/ST/Persons with Disability).



Learning Programme. Dr. Pai is on the Editorial Board of the WIPO-WTO IP Teachers Colloquium Annual Research Papers.

In 2013, Dr. Pai was nominated as a legal member in a committee constituted by the Ministry of Health, Government of India, for invoking provisions of compulsory licensing under the Patents Act, 1970, in the context of affordable healthcare. He was also the member of an expert committee constituted by the Ministry of Commerce to study the need for utility models in India (2013). He was part of the Committee for Evaluation and Continuation of the Scheme of Promotion of Copyright and IPR Beyond the 12th Five Year Plan (2012- 2017) constituted by the DPIIT, Ministry of Commerce and Industry. He has a PhD in the area of Standard-Essential Patents from the Inter-University Centre for IPR Studies, CUSAT, Kochi, India. Dr. Pai has contributed in peer-reviewed journals, edited book chapters, reports, newspaper editorials etc.
