## **NOTIFICATION**

COUNSELLING NOTICE FOR ADMISSION TO FOREIGN NATIONALS AND OCI/PIO CATEGORY FOR B.A.LL.B. (HONS.) PROGRAMME

The University has earmarked 10 seats for Foreign National Category (5 seats for Foreign Nationals & 5 seats for OCI/PIO) to be filled on the basis of academic merit of the qualifying exam. The admission to Foreign Nationals & OCI / PIO Category will be made as follows:

- i. The eligibility condition for admission of students under the Foreign Nationals Category shall be 65% marks in the Higher Secondary School Examination of (10+2) system or an equivalent examination.
  - Definition of Foreign Nationals: The candidate who possess citizenship of a country other than India and hold a valid passport of foreign country.
    - Definition of Overseas Citizen of India (OCI) / Person of Indian Origin (PIO): As notified by the Govt. of India.
  - The list of candidates who have applied for admission under the Foreign Nationals & OCI / PIO Category is available as Annexure-A.
  - The candidates are required to upload the following self-attested documents latest by May 22, 2023 at link given below in order to participate in the counselling process for admission under the Foreign Nationals and OCI/PIO Category:

- a) Certificates including Marks statement of XII Class or equivalent examination. Statement of marks downloaded from Digi Locker will also be accepted.
- b) Copy of the Passport
- c) Copy of OCI/PIO card (if applicable)
- d) Equivalence Certificate (if available)
- e) Online application Form Number
- The marks statement/documents and counselling fee received after May 22, 2023 will not be entertained.
- Counselling Fee of ₹1,00,000.00 (Rupees One Lakh Only) shall be paid through the link <a href="https://rzp.io/l/WSRVIofX">https://rzp.io/l/WSRVIofX</a>
- The University will issue provisional Merit List of only those candidates who have paid the Counselling Fee and provided the aforesaid documents in

order to decide the merit for the Foreign National and OCI/PIO candidates latest by May 25, 2023.

- The University will announce the First List of Provisionally Selected Candidates on May 25, 2023.
- The candidates, whose name are in the List of provisionally selected candidates, are required to pay the balance fee May 31, 2023 failing which the Provisional Admission Offer will automatically stands cancelled & Counselling Fee paid will be forfeited.
- A payment link will be given to the provisionally selected candidates for payment of balance fee. The University will issue the waiting List of only those candidates who have participated in the online counselling process. In case, any vacancy arises due to withdrawal of admission or non-deposit of balance fee by the provisionally selected candidate within the stipulated time-period (latest by May 31, 2023 the seat shall be filled up from the Waiting List candidate(s) only.
- Request for payment of fee after the last date will not be considered under any circumstances.

- The University will refund the Counselling Fee of only those candidates, who have paid the counselling fee but could not find a place in the provisional merit list for admission due to higher cut off. The University will be able to initiate the said refund in such case(s) only after June 20, 2023 or on the completion of admission process whichever is earlier. The counselling fee will be refunded/remitted to the same account from which it was paid. No requests of depositing it in any other account will be entertained.
