#### **CALL FOR APPLICATIONS**

**Position**: The National Law University, Delhi ("University") is seeking to engage, on a contractual basis, professionals for the following positions concerning the Centre on the Death Penalty at its campus in Dwarka, New Delhi:

- 1. One communication designer for conceptualising and designing the branding for the Centre. Branding to include designing of logo, visiting cards, letterheads and envelopes.
- 2. One website designer and developer for conceptualizing and designing the website for the Centre.

**About the Centre:** The Centre was established in August 2014, in succession to the Death Penalty Research Project ("Project") at the National Law University, Delhi. The Project commenced in July 2013, with the objective to analyse the socio-economic profile of prisoners sentenced to death across India and map their interaction with the criminal justice system. An overwhelming observation during the course of the Project was the poor state of legal representation received by prisoners on death row at all levels of the judicial process. Preliminary findings indicate that while a majority of the prisoners hire private lawyers for proceedings before the trial courts and high courts, most prisoners are represented by legal aid lawyers at the Supreme Court. Therefore, the problem of ineffective counsel for prisoners sentenced to death in India cannot be cast only in terms a of the broken legal aid system. In order to ensure realisation of the right to fair trial, the Centre seeks to provide access to competent and effective legal representation to all indigent prisoners sentenced to death in India. Working with a wide network of lawyers, the Centre is currently involved in the legal representation of over 30 prisoners on death row before the Supreme Court and high courts. Along with securing access to adequate legal representation, the Centre believes that there is an emerging need to expand the contours of the current judicial and public discourse around the death penalty through focused research. Sentencing policies continue to be absent in India and the Centre seeks to invest significant resources into researching and developing relevant sentencing frameworks in death penalty cases.

  - i. Graduate in graphic and website design.

  - iii. Prior experience of conceptualising and designing social science materials would be preferred.
- b. Website developer:
  - i. Minimum two years' experience of working with website development (UI/UX).
  - ii. Availability to complete the assignment by 10 January 2015.
  - iii. Prior experience of conceptualising and designing social science materials would be preferred.

### Proposals and their evaluation

Interested applicants are requested to send a detailed work proposal as per the requirements of this call, indicating possible timelines and approximate cost for the assignment. The University is aware that a precise costing might require further details but applicants are requested to indicate approximate figures based on the information provided in this call. Applicants are also required to send their resume and at least two samples of previous work. In finalising successful applicants, the University will consider quality of previous work, relevant experience, along with the costing provided.
