Position: National Law University, Delhi ('University') is seeking to engage, on a contractual basis, **one** full-time **RESEARCH FELLOW** (**LAW**) for the **Centre for Law**, **Justice and Development**, at its campus in Dwarka, New Delhi.

About the Centre: The Centre for Law, Justice and Development envisions revisiting, analysing and engaging with the development discourse and its interface with the legal discourse with the aim to participate in, contribute to and endeavour to mould the discourse as well as operationalisation of varied notions within the same in ways geared towards securing just domestic and international order. Role of the Research Fellow: The Research Fellow will assist the Centre in conducting high quality research for its various ongoing projects. As part of the assigned research project, the Research Fellow is expected to engage in diverse research activities including field work, data collection, data analysis, report drafting, etc. The Fellow will also be required to supervise the work of student researchers working on the projects, assist the Directors in organizing events/workshops/conferences around the projects and any other activities associated with the projects. The Fellow will also be expected to participate in other activities of the Centre, and undertake administrative responsibilities and institution building exercises at the Centre. Given the requirements of the centre and its work candidates based in Delhi will be preferred.

Qualifications: Applications are invited from interested candidates holding an undergraduate or postgraduate degree in law. Strong research and writing skills are essential. Note that this is an entry-level position and would be ideal for individuals with 0-2 years experience.

Duration & Remuneration: Salary will be commensurate with qualifications and experience and will be in the range of **Rs. 25,000 – Rs. 35,000 per month**. The position will be for a period of two years. Candidates should therefore apply only if they are available for the position for the entire duration. The selected candidate will be expected to join the Centre as soon as possible, and in no case later than November 1, 2018.
