#### ABOUT THE SEMINAR:

Higher education institutions around the world are incorporating Information and Communication Technology (ICT) to develop teaching, learning, and research to bridge the educational divides. As defined by UNESCO "Digital learning resources are offered online, freely and openly to teachers, students and independent learners in order to be used, adapted, and expanded in teaching, learning, and research. These include learning content, software tools to develop, use and distribute, as well as implementation resources." Recently, Open Educational Resources (OERs) and Massive Open Online Courses (MOOCs) have gained momentum in the fields of education and research. Further, this has exemplified the dimensions of researchers for potential and sustainable quality development with regard to demographic, economic, and geographic educational boundaries along with promoting life-long and personalised learning. OERs are teaching, learning, and research resources that reside in the public domain or have been released under an intellectual property license that permits their free use. MOOCs are a generic term used for all initiatives involving provision of online courses on a massive scale. In view of this, the seminar is designed to deliberate on various facets of OERs and MOOCs.

#### **OBJECTIVES OF THE SEMINAR**

The broad objectives of the seminar are as follows:

- ✓ To deliberate on the concept of open education through ICT in Higher Education to bridge the divides in education.
- ✓ Provide exposure to the participants on OERs.

#### **CALL FOR PAPERS**

Select papers from experts practicing in the area of development of MOOCs and OERs are invited, based on the themes and related aspects. The papers should be based on research surveys, case studies, or action plans rather than theoretical explanations. Submission of full papers (not more than 8-10 pages) with an abstract (approximately 200 to 400 words), keywords, and references to be formatted in—sized as an A4 size paper with margin 1.5 cm on all sides, in MS Word format, in 10 points, New Times Roman type, and single line spacing. Length of the paper should not exceed 4000 words. Details such as name of the author, designation, title of the article, abstract, name of the affiliating institution, mailing address, telephone number, fax number, and E-mail address are to be included. The paper may be submitted not later than 31st October 2019 to the Conference Secretariat. The paper submitted must not have been previously published or presented elsewhere. The Programme Committee will have the right to edit the papers. Selected papers will be published by a reputed publisher in the form of an Edited Book with ISBN number in print or digital format.

This seminar is intended for multiple audiences including faculty members of all disciplines, higher education administrators, library professionals, and research scholars from all disciplines of academia. A limited number of participants will be allowed to attend the seminar.
