



## World IP Day 2023

### Women and IP: Accelerating Innovation and Creativity

#### Background

The theme for this year's World Intellectual Property Day is Women and IP: Accelerating Innovation and Creativity. It celebrates the “can do” attitude of women inventors, creators and entrepreneurs around the world and their ground-breaking work.

The theme fittingly reflects Prime Minister Modi's vision on “Nari Shakti (women power)” playing a vital role in India's socio-economic developmental journey in the next 25 years. Women's economic empowerment is also a key focus of India's G20 agenda. It is also in line with one of the three thematic priorities of Foreign, Commonwealth and Development Office (FCDO) International Women and Girls Strategy 2023 to 2030, which is empowering women and girls.

To mark the World IP Day 2023 and India's G20 initiatives on women empowerment and to contribute to the above discussion, National Law University Delhi (NLUD), the Indian IPO and IPO of the UK will come together to host this event that will have panel discussions with inspiring professionals, discussing the role of IP in women empowerment and how IP has supported their growth as inventors, creators and entrepreneurs. Discussion will focus on inspiring career journeys of influential women inventors, the importance of encouraging more women to participate in the IP system, any barriers to women's participation in innovation and IP, opportunities to ensure inclusion of more women in the IP system, and how to measure the progress.
