### About the National Law University Delhi

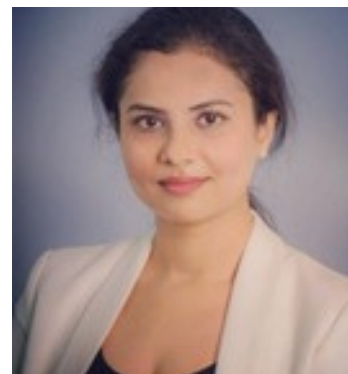
