# Call for Applications for Consultant (Designer) for Calendar 2021

# **Responsibilities:**

- A. Creative input relating to developing a suitable design for the calendar for the year 2021.
- B. Working on illustrations for the calendar based on the design and theme.
- C. Creating and communicating design options and illustrations suitable for the calendar.
- D. Finalizing the design and illustrations for the calendar, based on feedback and in coordination with the staff.
- E. Coordinating the printing process, verifying printed samples, making sure the calendar is printed as per the specifications and within the required time frame.

### **Qualifications:**

- A. Graduate in Fine Arts or Graphic Design or both.
- B. Relevant experience of working as a designer.
- C. Relevant experience of working with a reputed graphic design firm.
- D. Good hold over design softwares like Adobe Photoshop, Illustrator, InDesign.
- E. Experience in working with print medium.

**Compensation:** Remuneration will be commensurate with qualifications and experience and will be Rs.30,000/- per month.

**Duration of the Contract:** The contract will be for three months duration.
