<u>CALL FOR APPLICATIONS: SENIOR RESEARCHER FOR THE FAIR TRIAL</u> PROGRAMME

The National Law University, Delhi ('University') through Project 39A (P39A) is seeking to engage, on a contractual basis, **one Senior Researcher** (**Legal Aid**) for the Fair Trial Programme ('Programme'). The contract will be for one year initially and can be extended on an annual basis at the discretion of the University. The Researcher will be responsible for undertaking research and systems reform efforts as part of the Programme on issues around criminal justice, legal aid and fair trials.

About Project 39A:

Project 39A (hereinafter 'P39A') draws inspiration from Article 39-A in the Indian Constitution on equal justice and signals the broadening of our work on the criminal justice system in India. We undertake litigation, research and outreach relating to forensics, torture, legal aid, mental health and criminal justice, and death penalty (for more information on P39A, visit www.project39a.com).

About the role: Access to effective legal aid is an integral element of securing procedural guarantees for individuals within the criminal justice system and protecting vulnerable communities from the excesses of the system. However, the quality of legal representation and support to persons in custody in the current system of state sponsored legal aid leaves much to be desired.

The legal aid team at Project 39A seeks to combine in-depth empirical research with on ground interventions to strengthen access to and quality of legal aid as an element of the right to fair trial. Interventions are grounded in rigorous empirical analysis of the functioning of the system, with regular assessment to ensure their continued efficacy. The team also engages in training and capacity building of lawyers and para legal volunteers towards securing widespread and effective reform of the system.

Towards this goal the Senior Researcher will be expected to undertake the following responsibilities:

Responsibilities

- 1. Leading the design and implementation of research projects that align with P39A's strategic goals;
- 2. Leading and undertaking fieldwork for the purposes of the project, including interviewing prisoners, police personnel and functionaries in various State and District Legal Services Authorities;

- 3. Collate, analyse and publish findings of the fieldwork and interventions;
- 4. Designing and implementing assessments of on ground interventions towards evaluating their efficacy and engaging with the quantitative and qualitative data emerging from such interventions;
- 5. Undertake high quality academic writing on relevant themes;
- 6. Designing and implementing training curriculum for various stakeholders;
- 7. Engaging with functionaries of state legal aid institutions on strategic reform efforts;
- 8. Present the work of P39A at appropriate forums;
- 9. Participate in and contribute to the overall research efforts at P39A;
- 10. Undertake administrative or any other work that may be necessary to further the aims of P39A.

Qualifications:

- A. Either an LLM or a Master's degree in criminology.
- B. Relevant work experience of at least 3 years.
- C. High degree of familiarity with the criminal justice system is strongly preferred.
- D. Candidates with prior field research experience and academic publications, particularly on access to justice issues will be preferred.
- E. This is a full-time position based in Delhi.

Compensation: The compensation will be commensurate with experience and qualifications.

Application Process: Interested persons may send their resume and a statement of purpose, explaining their interest in working on issues of legal aid in the criminal justice system and the contribution that they see themselves making through this position. The statement of purpose must not exceed 750 words.

Deadline: Applications must reach us no later than 31 March, 2022, after which the applications will not be accepted.

Shortlisted candidates will be informed latest by 8 April 2022. Dates for the subsequent rounds of shortlisting and interviews will be announced subsequently.
