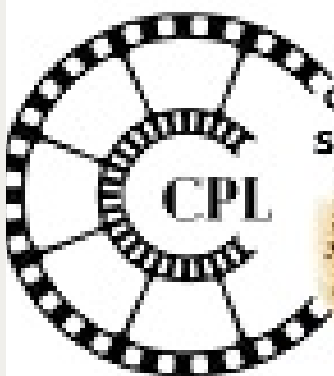

- 1. Abstract submission must be strictly in MS Word format only. Submission made in any other format shall not be considered.**
- 2. The MS Word file must be named in the manner which is as follows:**
  - a) Name of the Author and Co-author (if any) followed by title of the work. (eg: Author, co-author- title)**
- 3. Co-authorship is limited to a maximum of two authors.**
- 4. Abstract shall not exceed more than 250-300 words including keywords (maximum 5). Author(s) name, designation and their affiliations are not included.**
- 5. Format: All submissions must be in Times New Roman, font size 12, justified and with w1.5 line spacing, Paper size: A4 Sheet with margin of 1 cm.**
- 6. Abstract must be accompanied by a Cover page which must include following details:**
  - a) Title of the Paper**
  - b) Name of the Author and Co-author (if any)**
  - c) Designation**
  - d) Affiliation**
  - e) Contact details of Author and Co-author (if any) (E-mail ID, Contact number etc.,).**

### **FULL PAPER SUBMISSION:**

- 1. Full paper submission must be strictly in MS Word format only. Submission made in any other format shall not be considered.**
- 2. The MS Word file must be named in the manner which is as follows:**
  - a) Name of the Author and Co-author (if any) followed by title of the work. (eg: Author, co-author- title)**
- 3. All submissions must be made in the English language only.**
- 4. Paper should be original and unpublished work of the author(s) and any form of plagiarism is strictly prohibited.**
- 5. Plagiarism criteria: 10 percent, excluding footnotes and bibliography.**
- 6. The word limit of the final full submitted paper should not be more than 4000 words.**
- 7. The author(s) must give a declaration of the originality of the work.**
- 8. The UGC Anti-plagiarism guidelines shall be adhered.**
- 9. Author(s) shall solely be responsible for the accuracy of statements, opinion and view presented in the paper.**
- 8. Full paper must be accompanied by a Cover page which must include following details:**
  - f) Title of the Paper**
  - g) Name of the Author and Co-author (if any)**
  - h) Designation**
  - i) Affiliation**
  - j) Contact details of Author and Co-author (if any) (E-mail ID, Contact number etc.,).**
- 10. Format for main body: All submissions must be in Times New Roman, font size 12, justified and with 1.5 line spacing, Paper size: A4 Sheet with margin of 1 cm.**
- 11. Full paper shall be submitted via email (email-id will be provided to those participants whose paper is accepted and will register themselves after paying the registration fee).**
