### **CALL FOR APPLICATIONS: Director (Strategic Development and Partnerships)**

Position: The National Law University, Delhi ("University") is seeking to engage on an annual contractual basis, one Director (Strategic Development and Partnerships) for Project 39A. The Director (Strategic Development and Partnerships) will be responsible for formulating and implementing our development strategy and media engagement.

**About Project 39A:** Project 39A, erstwhile Centre on the Death Penalty, draws inspiration from Article 39-A in the Indian Constitution on equal justice and signals the broadening of our engagement with the criminal justice system in India. The Project undertakes litigation, research and outreach relating to forensics, torture, legal aid, forensic psychiatry and death penalty (for more information on Project 39A, visit www.project39a.com).

Project 39A is headed by the Executive Director, Dr. Anup Surendranath (Assistant Professor, National Law University Delhi) and has 17 full-time associates involved in litigation, mitigation, research and public outreach. This position will directly report to the Executive Director of Project 39A.

#### Responsibilities

- Planning and implementing key development strategies;
- Identifying and managing relevant funding opportunities;
- Developing strategic partnerships domestically and internationally;
- Communicating and coordinating with key partners and relevant stakeholders;
- Coordinating media strategies;
- Supervising production and dissemination of public relations materials.

## Qualifications

- Masters in Law or Humanities;
- Minimum 10 years of professional experience;
- Familiarity with law and issues in the Indian criminal justice system;
- Previous experience of designing and implementing development strategies for organisations working on issues of criminal justice;
- Previous experience of grant administration;
- Highly effective project management skills;
- Strong relationship management skills with a range of stakeholders;
- Experience communicating to external and internal audiences.



Compensation: Salary will be commensurate with qualifications and experience and will be approximately between INR 1,00,000 - 1,30,000.

Application Process: Interested persons may send their resumé and a brief statement outlining the contribution that they see themselves making to our work. The statement of purpose must not exceed 500 words. Please email your resumé and statement of purpose to p39@nludelhi.ac.in.
