6. The University is not bound to accept the lowest bid.
7. The work shall be carried out as per the directions of the Consultant (Technical)/AE (E)
8. Certificate by the Agency that “I have inspected the site and rates are quoted accordingly” is also to be enclosed.
9. The material shall be as specified in the bid document and got approved before supply at site.
10. The rate shall be inclusive of all taxes including GST etc. and nothing extra shall be paid on this account.
11. Any damage or loss to the existing site of work shall be got repaired by contractor with their own cost.
12. If work is not completed within the stipulated period without justified reason {The justification shall be with the satisfaction of Consultant (Technical)/AE (E)}, the order will be cancelled and DD will be forfeited and no claim for any loss on this account shall be entertained.
